

# Code of Conduct & Photo Release

The purpose of this policy is to provide a code of conduct for any and all Stupid Cancer community members who choose to attend CancerCon Live. It applies to all individuals present at all times when attending CancerCon Live on premises at the Omni Hotel Atlanta at CNN Center.

#### I agree that I will:

- Treat everyone in the AYA cancer community with dignity, respect, and worth.
  - I make a commitment to be non-judgmental about the cultural differences, living conditions, beliefs, and/or lifestyles of other Stupid Cancer community members.
  - I will refrain from making insensitive or offensive comments about politics, religion, race, gender identity, sexual orientation, or other potentially sensitive topics.
- Report any emergencies to the appropriate staff or onsite authorities immediately to ensure the health and safety of attendees and all members of the community.
- Keep conversations confidential so that breakout sessions and social activities are a safe space for all.
- Be cautious when requesting or sharing personal details, including medical and contact information (email, phone number, social media). Maintain appropriate boundaries both within and outside of Stupid Cancer mediated environments, and respect that other community members may prefer not to socialize outside of a Stupid Cancer setting.
- The Omni Hotel Atlanta at CNN Center is a smoke-free hotel. I agree to abstain from the use of all tobacco products, recreational drugs, and excessive alcohol consumption on site.
- The Omni Hotel Atlanta at CNN Center permits dogs under 100 pounds with advance notice, but only licensed service animals will be permitted in CancerCon sessions, activities, and Exhibit Hall. I agree I will not bring my pet to any CancerCon activities if it is not a certified service animal with proper documentation.

#### Accountability

Stupid Cancer reserves the right to remove any community member from a program for not adhering to this Code of Conduct or behaving in an abusive or inappropriate manner.

### Acknowledgement and Consent

I recognize that Stupid Cancer, as the program producer, will be the copyright owner of all photographs, video/audio recordings and all media, products or content subsequently generated from those materials, and I waive any right to royalties or other compensation arising from or related to their creation or use. I understand that images and recordings may be edited, copied, exhibited, published or distributed and waive the right to inspect or approve the finished product wherein my likeness or personal information appears.

I further agree not to record or broadcast any portion of the conference without the prior written consent of Stupid Cancer, unless I have validly registered for CancerCon as a member of press and received press credentials, in which case I agree to abide by the terms of the CancerCon Media Policy. Still photography is permitted for non-commercial purposes with the permission of those being prominently photographed.

I understand that noncompliance with this policy is grounds for exclusion from this and future events. I also confirm that, if I am registering as an exhibitor and to the extent any presentation or exhibit materials I utilize will include third-party material, I have obtained permission for its use consistent with the scope of this license.
